

Key Peninsula Community Plan

Schedule before the Pierce County Planning Commission

The Pierce County Planning Commission will hold a series of hearings on the proposed Key Peninsula Community Plan on Wednesday evenings in May. The location of all public hearings with the exception of the Study Session will be at the Key Peninsula Lutheran Church – McColley Hall. A Study Session will be held at 8:30 a.m. on April 24 at the Pierce County Annex Public Hearing Room, 2401 S. 35th Street, Tacoma. The Study Session is for staff presentation to the Planning Commission and there will be no public testimony taken. The Planning Commission will hear staff presentation and public testimony on specific topics on certain dates as shown below. It is anticipated that no action will be taken until May 23, 2007, at which time the Commission will make their recommendations. Public testimony will be taken only on the element presented at that meeting. The public hearings will be held at:
